### Acknowledgment of Risks, Injury & Obligations

I acknowledge that the activity I am to undertake may be a dangerous activity and that by participating in it I am exposed to certain risks. I acknowledge and understand that while participating in such activity:

- I may be injured, physically or mentally, or may die:
- My personal property may be lost or damaged;
- Other persons participating in such activity may cause me injury or may damage my property;
- I may cause injury to other persons or damage their property;
- The condition in which the activity is conducted may vary without warning:
- I may be injured or die or suffer damage to my property as a result of the negligence or breach of contract of Wallace County Rec Center;
- There may be no or inadequate facilities for treatment or transport of me if I am injured;
- I assume the risk of and responsibility for any injury, death or property damage or loss resulting from participating in the activity.

#### Release and Indemnity

I participate in the activity at my sole risk and responsibility. I release, indemnify and hold harmless Wallace County, Wallace County Rec Center, its servants and agents, Board of Directors, Officers and members, and Sunflower Bed and Breakfast from and against all and any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of any injury, loss, damage or death caused to me or my property whether by negligence, breach of contract or in any way whatsoever.

#### Administration

No one under the age of fourteen years (14) will be permitted to enter Wallace County Rec Center. Members age fourteen and fifteen must be with a parent or legal guardian while using the fitness center. Shared access with a non-member will result in forfeiture of WCRC useage effective immediately.

Appropriate covered footwear and a shirt must be worn at all times while in the fitness center.

Each member must respect other members and behave in an appropriate manner at all times.

Wallace County Recreation Department reserves the right to rescind the rights of members not complying with the terms and conditions of the membership, reserves the right to refuse membership to any applicant, and to change any of these rules and policies at any time.

This facility is unattended. Members agree to clean up after themselves, wipe down equipment after use, and make sure lights, TVS, fans and equipment are turned off. All weights and equipment must be put back after use.

Members are asked to report any damage to the facility or equipment, or anything that needs attention to the appropriate posted contact immediately. Smoking and alcohol are are prohibited on the entire property of the Wallace County Rec Center.

## **Rules and Regulations**

- 1) Facility Hours: The Wallace County Rec Center is available to use 24 hours, accessible with your PIN code, fob, or key card.
- 2) 24 Hour Video/Audio Surveillance at all times.
- 3) Wallace County Rec Center makes no assessment of your health status in participating in any type of program or activity. Please consult your physician prior to beginning any type of exercise program.
- 4) All participants/users must sign a "Wallace County Rec Center Membership Form" prior to using the facility.
- 5) No one under the age of fourteen years (14) will be permitted to enter Wallace County Rec Center. Members age fourteen and fifteen must be with a parent or legal guardian while using the fitness center.
- 6) Report any accident(s) immediately to the Wallace County Recreation Department @ 785-821-3831 or 785-462-0139. This includes spills and breakage of equipment.
- 7) Dress Code: Shirts or tank tops must be worn at all times.

Clean, Non-marking soled shoes must be worn at all times.

No sandals, open-toed shoes, or boots are allowed.

Carry in shoes, no outside shoes. Shoes must be free of rocks, sand and mud.

- 8) Food, beverages, pop cans or open cups are NOT allowed in the building. Only drinks in closed, non-breakable containers are allowed in the facility.
- 9) Treat all equipment with care and disinfect each machine when you are finished using it. Cleaning supplies are provided for wiping the equipment off.
- 10) If you are unsure of how the equipment works, to avoid injury . . . DO NOT USE.
- 11) No cussing, harassing, intimidating behavior or physical exchange will be tolerated.
- 12) No bicycles, skates, skateboards, rollerblades, pets of any kind are allowed in the building.
- 13) No alcohol, tobacco or illegal drugs are allowed on the property.
- 14) Lost or damaged equipment will be the responsibility of the individual to replace.
- 15) The Wallace County Rec Center is not responsible for lost or stolen property. Members are discouraged from bringing valuable items to the Wallace County Rec Center.
- 16) In an emergency, i.e. fire, exit and call 911. Move across the street in the quickest manner possible. The closest tornado shelter is in the basement of the Sunflower Bed and Breakfast.
- 17) Misuse or abuse of the facility or equipment will not be tolerated. The Wallace County Rec Center has video surveillance and will be monitored. Your access will be revoked and fob/card must be returned &/or will be deactivated.
- 18) Wallace County Rec Center may revoke key privileges at the Wallace County Recreation Department Board of Directors discretion and there is a zero tolerance level. This includes, but is not limited to, conduct that constitutes safety hazards, physical abuse, mental abuse, or failure to comply with the Wallace County Rec Center Rules and Regulations.
- 19) A First Aid Kit is located in center room attached to the wall.
- 20) A Hazardous Waste kit is located the center room attached to the wall.
- 21) NO EQUIPMENT should leave the Wellness Center.
- 22) NO EQUIPMENT can be brought into the Wallace County Rec Center without the Wallace County Rec Center approval.
- 23) All participants must leave the premises clean and make sure lights, TVs, and equipment are turned off.
- 24) Wallace County Rec Center has the right to change any of these rules and policies at any time.
- 25) Remember the facility rules are for everyone's safety and enjoyment. Please respect other participants at all times.

Before signing this document, I have read, understand and hereby agree to the terms and conditions of membership as defined on this membership form and know that it affects me legal rights. If family members (14 years and older only) use the facility, I agree to assume personal responsibility for the use of this facility by family members.
